Problem Statement by Martin Mutesasira on case Angela Cortez



The patient is a 17-year-old female presenting with complaints of a lack of energy and fatigue for almost two months. The symptoms have been associated with weight gain and irritability. In addition, the symptoms have led to a decline in school performance and challenges in participating in the usual pleasurable activities. The patient reports that she has been crying more than usual. She also denies active suicidal ideation. Acne and striae are also noted.

Management Plan by Martin Mutesasira on case Angela Cortez



Angela is diagnosed with depressive disorder. She will be referred for psychotherapy and pharmacotherapy in a setting appropriate for adolescents. Fluoxetine is recommended for the patient, with appropriate adjustment of dose depending on outcomes of observation for more than four weeks. Cognitive behavioral therapy would be appropriate for the patient.

Discuss common side effects of SSRIs, including a decrease in appetite, nausea, vomiting, and problems with sleep

Assess the patient for potential suicide risk considering her suggestion that she wishes to disappear

Educate the patient and family about the diagnosis

Recommend a nutritionist to the patient to address weight problems

Schedule a follow-up for the patient in four weeks
